## COMMISSIONERS PROCEEDINGS

March 4, 2024

The Pierce County Board of Commissioners met pursuant to adjournment on Monday, March 4, 2024, at 9:10 A.M. with the following members present: Tom Kuether, Brad Albers and Carl Martinson. Co. Clerk Shannon Wragge, Hwy Supt. Brian McDonald, Zoning Adm. Heather McWhorter, Co. Attorney Ted Lohrberg, Bonita Lederer and News Reporter Randee Falter were present.

Notice of the meeting was given in advance as shown by the Certificate of Publication on file in the County Clerk's office. Availability of the agenda was communicated in the advance notice of the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Chairman Kuether called the meeting to order at 9:10 A.M. and presided. Chairman Kuether stated that the Open Meetings Act is posted on the north wall of the board room with more copies available at the County Clerk's office.

Bonita Lederer was present to update the Board on the updating of the 2025 Lower Elkhorn NRD Hazard Mitigation Plan.

Hwy Supt Brian McDonald was present and discussion was held on Bridge #3405, the paving of the S & A Feedlot Rd and paint striping of hard surfaced county roads.

Motion by Albers, seconded by Martinson, to authorize Hwy Supt. Brian McDonald to proceed to get emergency bid quotes and negotiate costs for Bridge #03405. Roll call vote: Aye: Kuether, Albers and Martinson. Nay: None. Motion carried.

Discussion was held on funding of safe routes, the 554A Project and on the RAISE (Rebuilding American Infrastructure with Sustainability & Equity) Grant the City of Norfolk and Madison County will be pursuing and wanting Pierce County Board to form a partnership with them to build up roads and infrastructure in Madison and Pierce County.
